

The Annual Parish Council Meeting was held in Bratton Fleming Village Hall on Wednesday 14 May 2013 at 7:30pm.

1. Election of Chairman and Vice Chairman

Cllr Benbow took the Chair for the Election of Chairman.

Cllr Shapland was proposed as Chairman by Cllr Prowse, seconded by Cllr Benbow. There being no other nominations Cllr Shapland was unanimously elected,

Vice Chairman

Cllr Benbow was proposed as Vice Chairman by Cllr Shapland, seconded by Cllr Prowse. All in agreement.

2. Apologies

Apologies for absence were received from Cllr Mrs V Worms

3. Police Report

PCSO Gareth Woolway reported that no incidents had been logged during the past month. It the same period 3 crimes had been reported: 1 possession of drugs; 1 theft of a bicycle; 1 domestic incident.

He reported that speed checks would be conducted shortly, and that the police would be increasing its visibility in the village in an attempt to deter vandalism etc.

It was reported that speeding traffic continued to be a concern for parishioners, both motor traffic and bicycles.

4. Public Participation

- 1. Mr St Clair enquired if the parish council had been in contact with the Planning Dept regarding the recently erected building at the Solar Park. The Chairman replied that the planners were dealing with it.
- 2. Mr St Clair why it was necessary to choose between a development boundary or a criteria based response to the Local Plan, and why not have both.

 Cllr Prowse explained why he considered a development boundary inappropriate.
- 3. It was noted that sites put forward for development appear on the SHLAA report.

 Concern was also expressed over the safety of the footpath joining the road just above The Old Workshop. The matter was referred to the Footpath Group.

9. Highways

It was reported that some road repairs had been carried out on the Bratton Fleming – Barnstaple road.

Cllr Benbow reported that the grass in Furze Park Rd had again not been cut. Cllr Prowse to pursue. It was reported that the ditch alongside the road below Rye Park had not yet received attention. Clerk to contact Highways.

Cllr Benbow reported that there would be a Drop-In session the following Tuesday, in the Village Hall 4:30-6:30pm.

11. Village Shop

Cllr Prowse reported that the original proposal was for an 100 year lease of the land, with the parish council paying to remove the covenant on the land.

In order to move the matter on it was agreed to accept the offer from Mr Cotton for him to pay for the lifting of the covenant for a reduced rent, subject to the agreement of the District Valuer.
