



A meeting of the Parish Council was held in Bratton Fleming Village Hall on Wednesday 19 April 2017 at 7:45pm.

**159. Recycle More presentation by Ricky McCormack from North Devon Council**

Ricky McCormack, head of Waste and Recycling introduced himself and explained the new arrangements for collecting waste. Bratton Fleming was included in the trial area which would be starting in June and would run for approximately six months. The trial area, a mix of rural and urban areas will affect 3500 properties. If successful the scheme will be rolled out across the whole area. New caddies would be delivered to all properties shortly for food waste, these will be collected weekly.

The free garden waste collection will be withdrawn and replaced by a fortnightly collection for an annual fee of £36.

The trial will see an enhanced recycling service, with an unlimited weekly collection.

Collection of the black wheely bins will move to a three-weekly collection.

Four new recycling vehicles will be equipped with new technology and will result in a quicker response to problems.

At present the recycling equipment at Brynsworthy is unable to cope with tetra packs, but when the equipment is replaced in a few years time, it will be possible to recycle drinks cartons.

Advisors will be visiting the trial area to answer any questions and discuss any problems that residents may have.

**162. Public Participation**

It was reported that Japanese Knotweed was present on the roadside verge near Bratton Cross.

It was reported that the rope on the lifebelt at the pond in the Community Woodland had been cut and the lifebelt thrown into the water. The latches on the hide had been broken, but there was no other damage.

**163. Declaration of Interests**

Cllr Prowse declared an interest in planning application 62907.

**165. Approval of Minutes of the meeting held 15 March 2017**

The minutes of the last meeting were agreed and signed as a true record.

**166. Matters Arising from Minutes of meeting held 15 March 2017**

A meeting had taken place at the White Hart, with the owner, agent, planning officer, DCC Highways and Cllr Prowse attending. It had proved to be a difficult meeting, with little progress being made. The current planning application was considered to be unacceptable. It was understood that the Community Group was moving forward.

Mr Milton had been made aware of the concerns over the abandoned car in the car park.

**167. Planning**

**1. Applications:**

62759 Variation of condition 6 ( life of the solar farm) attached to planning permission 51698 installation of a 5 mw solar energy park (amended plan & supplementary documents) to allow an additional 5 years land adjacent to Four Cross Way Bratton Fleming.

**It was resolved** not to raise any objection to extending the life of the solar park, but to request that any planning consent should include a community benefit package.

62907 Prior approval for a change of use of agricultural building to a dwellinghouse (qa & b) The Linhay Rye Park Bratton Fleming

There were no objections raised.

### **171. Highways**

Concern was expressed over the speed of traffic through the village.

A pothole was reported, next to the manhole cover near the bus shelter.

Fly tipping was reported at the top of Grange Hill and at Knightacott.

### **172. Reports**

#### **1. District Councillor's Report**

Cllr Prowse offered his apologies over the decision by NDC to remove Pay on Exit at Barnstaple car parks. Attempts of getting the decision reversed had been unsuccessful.

There had been little movement on lifting the covenant to allow the siting of the shop at the entrance to the Millennium Green. The decision from the Exeter Diocese was still awaited.

NDC had purchased all the fixtures and fittings at the two theatres. Parkwood Theatres would be running the theatres on behalf of the council as a short term measure until a more permanent agreement can be made.

An application had been submitted for phase II development by Wainhomes. This had been submitted on the basis that there was still a shortage of housing land. Planning approval would mean that it would be necessary to dig up Goodleigh Road again. It was hoped that any inconvenience could be kept to a minimum. DCC had incorrectly stated that utility companies had a right to close the road.
